DEAR SIR SEATTLE LOCAL ONE SEVEN FOUR MEN ARE NOW WORKING FOR BIRCH JOHNSON LYTTLE CONTRACTORS AT LADD FIELD FAIRBANKS ALASKA STOP MANY HAVE BEEN WORKING THERE MORE THAN THIRTY DAYS AND HAVE NOT CLEARED OR TRANSFERRED INTO LOCAL ONE EIGHT THREE OF FAIRBANKS STOP AL CROWDER OF LOCAL ONE SEVEN FOUR HAS APPOINTED A MEMBER OF ONE SEVEN FOUR AS SHOP STEWARD TO REPRESENT THEM STOP WILL YOU PLEASE SEND US A WIRE CONFIRMING OUR JURISDICTION HERE SO THAT BIRCH JOHNSON LYTTLE WILL HAVE IT CLEAR THAT ONE EIGHT THREE HAS JURISDICTION HERE STOP ALSO PLEASE INFORM LOCAL ONE SEVEN FOUR THAT THEIR MEN ARE VIOLATING ARTICLE SEVENTEEN SECTION THREE OF THE INTERNATIONAL CONSTITUTION BY NOT TRANSFERRING INTO ONE EIGHT THREE YOURS TRULY=
